Sub: **Lot size for delivery of CMR.**

Ref: **This Office letter No.7407 dt.20.04.2011.**

Sir,

Inviting a reference to the subject cited above, I am to say that the size of each lot / consignment of CMR has been discussed in the weekly review meeting on Procurement Operation on 26.04.2011.

2. After careful consideration, it has been decided in that meeting that the size of each lot /consignment to be received at RRC of the Corporation will be **20 MT (400 bags of 50 kg packing)** except in case of last or only consignment of CMR. District where delivery at **27 MT (540 bags of 50 kg packing)** lot size is in practice, may continue with that system to avoid dislocation in delivery of CMR.
3. Receipt of 20 MT lot size shall be in the RRC under Corporation management, in the CWC/OSWC godown in use by the Corporation & in the hired godown under their management.
4. FCI authorities have given consent to verify the stock on receipt of stock in RRC with lot size of 20 MT.
5. However, delivery to FCI shall be at 27 MT (540 bags of 50 kg packing) except in case of last / only consignment of CMR.

This is for your information and necessary action. It is requested to circulate the same amongst all field functionaries for strict implementation with immediate effect.
