Sub: Participation of Rice Millers of nearby districts in procurement operation in Angul, Dhenkanal, Deogarh, Subarnapur, Kalahandi, Jagatsinghpur, Kendrapara & Keonjhar .

Ref: F.S. & C.W. Deptt. Letter No.18407 dt.16.10.10 (Food & Procurement Policy for KMS- 2010-11) and this office letter No.16721 dt.20.10.10 (operational guideline for KMS-2010-11).

Sir,

Inviting a reference to the letters on the subject cited above, I am to say that in clause - 8 (xiii) of Food & Procurement Policy of Government, it has been mentioned to utilise the millers from other nearby districts in case of districts where adequate numbers of millers are not available. The said provision has also been stipulated in clause- 11(xii) of the operational guidelines of the Corporation. These provisions are intended to ensure that procurement operations in a district do not hamper due to inadequate milling capacity and surplus milling capacity of a district does not remain idle.

During the last KMS- 2009-10, custom millers of nearby districts have participated in procurement operation in the districts having inadequate milling capacity. Some of those millers have delivered their dues earlier than the existing millers of the district having inadequate milling capacity.

As the services of the custom millers are required in paddy procurement operation for the KMS 2010-11, it is requested to recommend the names of the sound custom millers basing on their past performance as to their working so that they can be allowed to participate in procurement operation during the KMS: 2010-11 in the districts having less milling capacity.

Such recommendation may be sent within a week as concerned districts can plan accordingly, where the procurement operation shall start shortly.




