Sub:- **Supply of Yellow Peas under PDS.**

Sir,

The Govt. in FS & CW Deptt., letter No.16593 Dt.16.09.2010 and No.17247 dt.23.09.2010 have allotted 4010M.T Yellow Peas for sale under PDS in the cities of Bhubaneswar, Cuttack, Berhampur, Sambalpur & Rourkela for two months. Yellow Peas shall be sold to the BPL, AAY & APL card holders on those cities as per actual weighment. The OSCSC is procuring Yellow Peas through NAFED and the same will be kept in the Zonal Depots at Mancheswar, Jagannathpur (Berhampur) and Bargarh for issue to respective CSO-cum-District managers. Copies of Govt. letters are enclosed for reference. Quantity allotted to each of aforesaid urban area per month is given below.



In this connection the concerned CSO-cum-District Managers are to follow the instructions given below.

1. The CSO-cum-District Managers of Khurda, Ganjam & Bargarh will earmark separate space in the zonal depot to store the Yellow Peas.
2. Yellow Peas will be issued on weighment under PDS through the Storage Agents on pre-payment basis. Similarly retailers (FPS) will lift stock on per-payment basis. For this purpose the storage agent shall deposit Rs.1214.90 per quintal of yellow peas with Corporation in advance. Retailers shall deposit Rs.1236/- per quintal with storage agents for such yellow peas. The Storage agents shall be entitled to receive transportation charges @ Rs.10.00 p.q for 1<sup>st</sup> 10kms and @ Rs.0.35p per quintal per km for subsequent kms for the distance covered. The distance for this purpose shall be fixed by the District Manager. The empty bags shall be retained by the retailer.


3. Yellow Peas will be sold to each BPL, AAY & APL card holder only @ 2.5 kg per card per month.
4. Yellow Peas will be sold to card holders @ Rs.12.60 per kg.
5. In each Fair Price Shop separate stock & sale register will be maintained. Full Signature / thumb impression of card holder will be obtained in the Sale Register. Thumb impression will be identified by another card holders / retailer that it is thumb impression of the card holder.
6. One or more delivery order (D.O.) book shall be exclusively used for yellow peas transactions. There shall be separate D.O. & D.O. control Registers, stock registers for yellow peas transactions. In operational cash book all expenses/incomes under yellow peas transaction shall be booked under the head "Yellow Peas A/C" for booking those in the General Ledger. A monthly statement showing item of incomes and expenditure under yellow peas trade shall be submitted to reach Head Office by 15<sup>th</sup> of the succeeding month.
7. Sale proceeds of yellow peas shall be sent immediately i.e. on the same day or at best the next day to Head Office by RTGS / CBS to Union Bank of India, Main branch , BBSR A/C No . 380804010024014 with a forwarding letter to Head Office.
